Responsibility for Data Processing

Processing of Personal Data

Special and/or Sensitive Personal Data

Purposes and Grounds for Processing

Retention Period for Personal Data

We retain your personal data only as long as necessary to fulfill the purposes for which it was collected. The following retention periods apply for each category of personal data:

Sharing Personal Data with Third Parties

We share your data with third parties only when necessary to fulfill our agreement with you or to comply with legal obligations.

Cookies or Similar Technologies

Our websites use only technical and functional cookies, as well as analytical cookies that do not infringe upon your privacy. A cookie is a small text file stored on your computer, tablet, or smartphone when you first visit our websites. The cookies we use are necessary for the technical operation of the websites and to enhance your experience. They ensure the websites function properly and, for instance, remember your preferences. We may also use these cookies to optimize our websites.

You can opt out of cookies by setting your internet browser to block cookies. Additionally, you can delete all previously stored information via your browser settings.

Data Review, Modification, or Deletion

You have the right to view, correct, or delete your personal data. You also have the right to withdraw your consent for data processing or to object to the processing of your personal data by L'O.P. Ortolanda.
